**Terms & Conditions:**

An incomplete application will not be accepted. Elko County Fairboard reserves the right to refuse any allocation of stalls to any horse (s), owner or trainer. The applicant understands that there may be numerous hazards and risks of injury to themselves, their agents, owners, employees, persons upon the race track and on the premises of the Elko County Fairgrounds, applicant agrees that the Elko County Fair Board or its assignees will not be liable for any injury, illness or loss suffered in any manner by horses, personnel, family or equipment. The Elko Co Fair Board, County or City of Elko does not provide any liability insurance for the activities of the horsemen or their employees, agents, vendors or guests. Stalls occupied by horses shall not be padlocked at any time. Occupied stalls must always be attended. Tack rooms are not to be used as living quarters as per Fire Marshall. Applicant acknowledges that security officers, and or law enforcement officers may search any stall assigned to him/her for any reason at any time. **Horsemen will be allotted stalls for horses approved to race at the Elko County Fair, with the understanding that the occupant of each stall allotted will have a minimum of one (1) start and that their horses are fit and ready to run. If the trainer does not comply such horse(s) not in compliance may be asked to vacate said stall(s) and be replaced by another horse or horses, or the stall(s) may be given to another trainer with a horse that is fit and ready to run.** Stalls must be reserved for all entries, **\$10.00 per stall with 50% due at time of reservation**, including entrants in the Elko County Quarter Horse Futurity and Derby, the Elko County Thoroughbred Futurity and Derby, the Utah Quarter Horse Futurity, and all horses with an intent to race during the Elko County Fair Race Meet whether in stakes, trials or overnight races. **Owners and Trainers are responsible for their own stall reservations.** Stall reservations must be made prior to July 15<sup>th</sup>, and only horses approved for stalls will be allowed on the grounds. Please specify the name stalls are to be issued to we will confirm all reservations. **Stalls ARE NOT transferable without permission of the racing office.**
